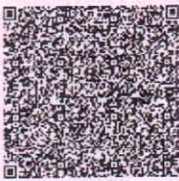

TRUST DEED



This deed of Charitable Trust executed on this 27th day of March 2021 by Puneet Sharma S/o Sh. Ved Ram Sharma R/o D-8 Sector-47, Noida-201301, Gautam Budh Nagar (U P) [Aadhar No : 5633 9452 7661] hereinafter called the 'Settlor' (which expression shall, unless excluded by or repugnant to the context, be deemed to include his executors, administrators and representatives).

WHEREAS, the Settlor is desirous of establishing a charitable Trust by the name of **"Aakash Educational Trust"** hereinafter called the "Trust" for the purpose of establishing a School and to run, support, and grant aid or other financial assistance to other schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.

AND, WHEREAS the Settlor has set apart, in favour of the Trust, a sum of Rs. 20,000/- (Rupees Twenty Thousand only) as the Corpus Fund for the establishment of the said Trust.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS:

1. That in order to effectuate his aforesaid desire, the Settlor has set apart and handed over to the Trustees, a sum of Rs.20,000/- (Twenty Thousand only) [hereinafter called the a 'Trust Fund', which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the Trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents], and the Trustees shall hold and stand possessed of the same

upon the Trust subject to the powers, provisions, agreements and declarations hereinafter contained.

2. That the name of the Trust shall be "**Aakash Educational Trust**" and its office shall, for the present, be situated at D-8 Sector-47, Noida-201301, Gautam Budh Nagar (U P), and/ or at such other place or places as the Trustees may decide from time to time. The office premise is not the property of the Trust.
3. That the objects for which this trust is established are:-
 - a) To establish, run, support, and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
 - b) To establish, maintain and run welfare centers for the promotion of pious nature, patriotism, character, health and social reformation amongst the public in general and/or to publish books, magazines, journals to promote the aforesaid objects.
 - c) To establish, develop, maintain and grant aid in cash or in kind to Hospitals, Medical schools, Medical colleges, Nursing Institutions, Dispensaries, Maternity homes, Child welfare centers and/or such other similar charitable institutions in India for the benefit and use of the general public.
 - d) To establish, maintain and run, studentship, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, color, race, creed or sex.
 - e) To promote, establish, support, maintain, or grant aid to institutions for the promotion of science, ayurveda, animal husbandry, agriculture, literature, music, drama and fine arts, for the presentation of historical monuments and for

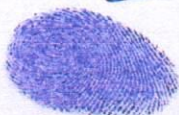

- f) To establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports clubs, dharamshalas and rest houses, used by public in general.
- g) To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
- h) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.
- i) To grant relief and assistance to the needy victims during natural calamities such as famine, earthquake, flood, fire, pestilence, etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.
- j) To grant aid and render assistance to other public charitable Trusts or institutions.

(II) Managing Trustee: The Settlor, Puneet Sharma, will be the Managing Trustee for life. He will be the Manager and Correspondent of the Trust; and shall act as Chairperson, and generally preside over all meetings of the Trust. He during his life time shall nominate his successor to be the next Managing Trustee, and on his failure to do so, the same may be appointed by the remaining trustees by a majority vote. The Successor to the Managing Trustee so nominated/ appointed may further nominate a Managing Trustee during his/her life time, and so on.

(III) Appointment & Total Number of Trustees. The Managing Trustee, with or without consultation with other Trustees, may appoint any additional Trustees, as desired or deemed fit. However, the total number of Trustees shall not exceed 'Twelve' at any given point of time.

(IV) Board of Trustees. The Board of Trustees will ordinarily consist of not less than 'Two' Trustees, who shall form a 'Quorum' for a Board Meeting of the Trustees, and empowered to pass a Resolution. All the Board Proceedings and Resolutions passed/ circulated shall be regularly recorded in a Minutes Book, which will be signed by the Chairperson of the Trust or the Trustee Chairing that meeting.

(V) OFFICE BEARERS OF THE TRUST:

The office bearers of the trust shall be appointed either from the existing trustees or public by the "Founder of the one part" and "Trustees of the other part" either by selection or by nomination or by mutual consent. The following will be the office bearers of the trust :

- a) Chairman
- b) Vice- Chairman
- c) Secretary
- d) Treasurer
- e) Manager

f) Such other posts as may be deemed necessary for the functioning of the trust or for all or any institution run by the trust for a specified period of time in writing during such appointment.

5. That the Trust fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time mentioned below:
- a) Money donated by Founder or trustees
 - b) Donations from India And Abroad
 - c) Educational Fees
 - d) Fees, donations etc. received from organizing function(s), programmes for objects of the Trust.
 - e) Fees earned through educational or other institutions, news papers and news agencies, etc.
 - f) Money earned through community centers.
 - g) Grants, Gifts, Contributions, donations in kind or cash or in any other mode other than cash from the government, semi-government, autonomous organizations ,industrial and business houses and private bodies.
 - h) Income from various investment
 - i) Contributions from other sources.
 - j) Any Other receipts :
 - i) The board of Trustees is authorized to raise loans to gain credit from any bank or any other financial institutions and to execute the necessary borrowing documents or create lien or the securities of the Trust to secure the borrowing as per present or future needs of the trust. In case of disputes/differences in this regard the decision of chairman/Settlor shall be final.
6. That the Trust fund shall not be applied for any purpose other than specified in Para 3 hereinabove.
7. That the Trustees should always maintain proper accounts of the Trust, which shall be kept at the office of the Trust.
8. That for the furtherance of the objects of the Trust, the Trustees shall have the following powers:

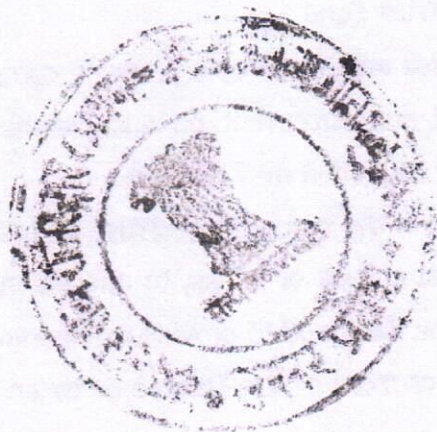

- (a) To accept any donation, contribution, grant or subscriptions in cash or in kind, from any person(s), body of persons or Trust, with or without conditions.
- (b) To apply the whole or any part of the income of the Trust, or the Trust fund or accumulation thereto, to any one or more of the objects of the Trust, as the Trustees may, in their discretion, deem fit from time to time.
- (c) To convert and deal with the Trust property and/or any investment for the time being.
- (d) To invest the Trust Fund as per the provisions of Section 11(5) of the Income Tax Act, 1961.
- (e) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- (f) To let out, demise any immovable property comprised in the Trust Fund for such period and such rent on such terms and conditions as the Trustees in their discretion may think fit.
- (g) To open account in the name of the Trust, or Institutions run/ conducted by the Trust with a Bank or banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustee or by an agent appointed by the Trustee.
- (h) To adjust, settle, compromise, compound, refer to arbitration, all action, suits, claims, demands and proceedings regarding the Trust fund.
- (i) To appoint constituted attorneys or agents and to delegate to such attorney or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.
- (j) To appoint or make provision for the appointment of any person (including all or any of the Trustee and committees or administrator or Managing Trustee or otherwise) for the purpose of the administration of

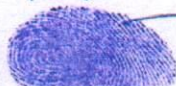

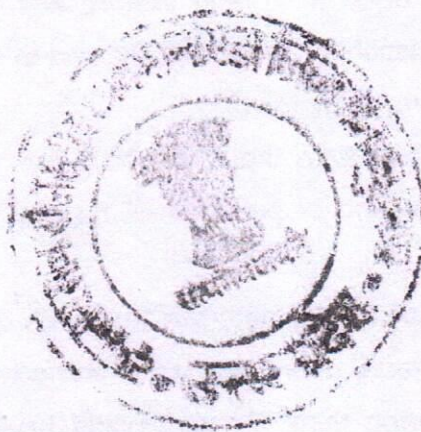

the Trust in such manner and subject to such rules and regulation as the Trustee may prescribe and also to appoint or provide for the appointment of separate Trustees to hold appointment of separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.

- (k) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- (l) To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscription made by them.
- (m) To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the Trust.
- (n) To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustee may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
- (o) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, organization or Trustee to start maintain, or carry out such charitable objects.
- (p) To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or

things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.

- (q) To borrow moneys either on the security of any property comprised in the Trust fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- (r) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money promoting the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.
- (s) To take over or amalgamate with any other charitable trust, society, association, or institution with similar objects.
- (t) To establish, promote, manage, organize or maintain or to assist in establishing, promoting, managing, organizing, or maintaining any branch of the Trust or any other Trust or its branch with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.
- (u) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- (v) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.

- (w) To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the trust, societies, institutions or associations with which this Trust is authorized to amalgamate.
- (x) On Dissolution, all the Trust Funds & Assets, whatsoever, will be Transferred and handed over to any other Society, Corporation, Institution, Trust or Organization on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Society, corporation, Institution, Trust or Organization having similar Charitable Objectives, with the powers, agreements and declarations, appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the Trust fund. The Trustees for the time being of these presents shall become discharged from the Trust hereof relating to Trust Funds so transferred.
9. The Trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omission or commission of the other Trustees, nor of any banker or other person with whom the trust properties or any securities may have been deposited or kept.
10. The Trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
11. The number of the Trustees shall not be less than two and more than eleven. If the number of the Trustees shall fall below two, the Trustees shall not, except for the purposes of filling of any vacancy, act so long number is below the said minimum.

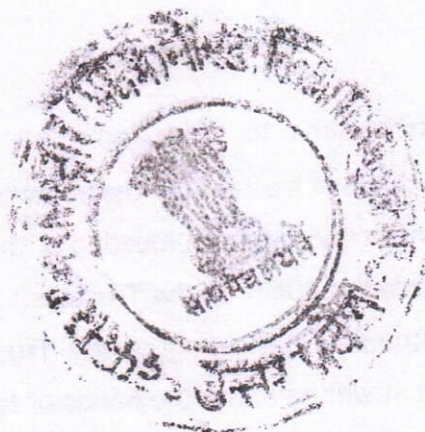

12. The Managing Trustees for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being consider proper. A person shall cease to be a Trustee either: (i) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer, or (ii) if he is requested to resign by 3/4th or as near thereto as possible of the remaining Trustees.
13. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.
14. The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations :-
- (a) Two Trustees shall form a quorum for a meeting of the Trustees.
 - (b) All matters will be decided mutually by the Trustees.
 - (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
15. The Trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall have binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.

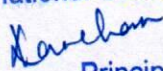
